**Events:** We will use the new IBF rules: 3x15 for doubles and men's singles events, 3x11 for women's singles.

Flights: A, B, C, D

Men's Singles, Men's Doubles, Women's Singles, Women's Doubles, Mixed Doubles

There will be consolation rounds in all events.

Partners must play at the level of the better player (i.e. a B player and C player must play in the B flight and above).

**Players playing multiple doubles or mixed flights must play with the same partner.**

Both partners of a doubles team need to send in individual entry forms.

Court warm-ups will be limited to 5 minutes, with a 10-minute default rule **STRICTLY** enforced.

**If participants do not show for their event(s) he/she will be charged for the event(s)**

Participants must pay for their events before they participate in the tournament.
